The Hon'ble Punjab and Haryana High Court vide order dated 16-12-2014 in CWP no. 4829 of 2011 and other petitions, had directed recasting the seniority of officers by keeping in view the observations of the Hon'ble Court. Accordingly, in compliance with the orders passed by the Hon'ble Punjab and Haryana High Court, a tentative common seniority list of ASIs/SIs/Inspectors (District & PAP) was prepared and uploaded on 11.11.2017 on the website of Punjab Police for claims/objections. After considering objections, inter-se-seniority list of Inspectors of Police as per the revised common seniority has been circulated by the office of Director General of Police, Punjab vide no. 1187-1286/E-1(1) dated 22.01.2018.
